This disorder is also often called a psychiatric disorder or mental disorder and in the general public is sometimes referred to as a nervous disorder. The purpose of this paper after discussing this case is expected to understand and provide nursing care to patients with sensory perception disorders: Auditory hallucinations. The design of this research is a case study, namely examining a problem through a case study consisting of a single unit. The location and time of this research was conducted at Dr. RSJ. Radjiman Wediodiningrat Lawang in the span of July 12 – July 26, 2022. In the case of Mr. S. He was brought to the RSJ by his wife and the village head on July 08, 2022 on the grounds that he went into a tantrum, looked confused, restless, had trouble sleeping, paced back and forth, spoke Mr. S is a mess, sometimes talks to himself, cries and smiles to himself. patient started relapse since 3 months severe 3 days. Nursing diagnoses that arise are sensory perception disorders: Auditory hallucinations. Planning researchers make nursing action plans in accordance with the theory including general goals, specific goals, and outcome criteria. In general goals, the client is expected to be able to recognize his hallucinations, while in special goals there are 5 special goals. The implementation is carried out in accordance with the nursing plan and the implementation strategy that has been made, including carrying out the specific general goals that have been set, namely Fostering a trusting relationship. Evaluation is expected that the patient is able to accept the nurse as a therapist and the patient is able to control his hallucinations.

Gangguan jiwa adalah kondisi dimana proses fisiologis atau mental seseorang kurang berfungsi dengan baik sehingga mengganggu dalam fungsi sehari-hari. Gangguan ini juga sering disebut gangguan psikiatri atau gangguan mental dan dalam masyarakat umum kadang disebut sebagai gangguan saraf. Tujuan penulisan ini setelah membahas kasus ini diharapkan memahami dan memberikan asuhan keperawatan pada pasien dengan gangguan persepsi sensori : Halusinasi pendengaran. Pada kasus Tn.S dibawa ke RSJ oleh istrinya dan pak lurah pada tanggal 08 juli 2022 dengan alasan masuk mengamuk, tampak bingung, gelisah, susah tidur, mondar mandir, bicara Tn.S kacau, kadang bicara sendiri menangis dan tersenyum sendiri. pasien mulai kambuh sejak 3 bulan parah 3 hari ini. Diagnosa keperawatan yang muncul yaitu gangguan persepsi sensori : Halusinasi pendengaran. Perencanaan peneliti membuat rencana tindakan keperawatan sesuai dengan teori meliputi tujuan umum, tujuan khusus, dan kriteria hasil. Dalam tujuan umum diharapkan klien dapat mengenal halusinasinya, sedangkan dalam tujuan khusus ada 5 tujuan khusus. Implementasi yang dilakukan sesuai dengan rencana keperawatan serta strategi pelaksanaan yang telah di buat diataranya melakukan tujuan umum khusus yang telah di tetapkan yaitu Membina hubungan saling percaya. Evaluasi diharapkan pasien mampu menerima perawat sebagai terapis dan pasien mampu mengontrol halusinasinya.
