The ability of a nurse to handle emergency cases such as stopping, stopping breathing by taking actions such as Basic Life Support or basic life support, basic life support is an effort that must be done immediately by someone if they find a victim who has stopped breathing, stopping heart, every health worker must have good and appropriate skills in providing Basic Life Support measures. The purpose of this study is to explain the long-standing relationship of nurses with basic life support capabilities based on the results of empirical studies. In this study using the Study Literature Review. Literature search is done through, google cindeka, google scholar and pubmed using the keywords long time working, long time working nurse, basic life support, basic life support capabilities, in searching journals found 30 articles that are the same as keywords and duplicated, from the results duplication found that there were 10 journals that match the research title using PICO analysis. Obtained from the analysis of journals there are 5 international journals and 5 national journals, the journal shows that there is a relationship between the length of work of nurses with basic life support. This shows that there is a correspondence between theory and journal from the results of the study of respondents doing Basic Life Support where the longer a nurse works, the better the capabilities, so that in handling emergency cases that require immediate assistance, it is carried out carefully, quickly and precisely according to operational standards to prevent the occurrence of disability or death. ABSTRAK

HUBUNGAN LAMA KERJA PERAWAT DENGAN KEMAMPUAN *BASIC LIFE SUPPORT*

Kemampuan seorang perawat dalam menangani kasus kegawatdaruratan seperti henti jantung, henti nafas dengan melakukan tindakan seperti *Basic Life Support* atau bantuan hidup dasar. *Basic life support* atau bantuan hidup dasar merupakan suatu upaya yang harus segera dilakukan oleh seseorang apabila menemukan korban yang mengalami henti nafas, henti jantung, setiap tenaga kesehatan wajib memiliki kemampuan yang baik dan tepat dalam memberikan tindakan *Basic Life Support*. Tujuan penelitian ini adalah untuk menjelaskan hubungan lama kerja perawat dengan kemampuan *basic life support* berdasarkan hasil *study empiris*. Dalam penelitian ini menggunakan *study Literature Review*. Pencarian *Literature* dilakukan melalui, *google cindekia, google scholar dan pubmed* dengan menggunakan kata kunci lama kerja, *long time working nurse*, bantuan hidup dasar, *basic life support capabilities*, didalam pencarian jurnal ditemukan sebanyak 30 artikel yang sama dengan kata kunci dan duplikasi, dari hasil duplikasi ditemukan terdapat 10 jurnal yang sesuai dengan judul penelitian dengan menggunakan analisa PICO. Didapatkan hasil analisa jurnal terdapat 5 jurnal internasional dan 5 jurnal nasional, dalam jurnal tersebut menunjukkan bahwa terdapat hubungan antara lama kerja perawat dengan *basic life support*. Hal ini menunjukkan terdapat kesesuaian antara teori dengan jurnal dari hasil penelitian responden melakukantindakan *Basic Life Support* Dimana semakin lama seorang perawat bekerja maka semakin baik pula kemampuan yang dimiliki, sehingga dalam penanganan kasus kegawat daruratan yang memerlukan pertolongan segera, maka dilakukan dengan cermat, cepat dan tepat sesuai standar operasional untuk mencegah terjadinya kecacataan atau kematian. Pelayanan kegawat daruratan merupakan peranan yang sangat penting bagi perawat karena (*Time saving is life saving*) bahwa waktu adalah nyawa.
